- Your membership is paid through December of the present year (unless you joined after Oct. 1, in which case your membership is paid through December of next year).
- As a member of P&M Trailriders you will receive discounts at all P&M sponsored events.
- You will receive (via email) a copy of our bi-monthly newsletter.

- P&M Trailriders is a working club, and as a member you are required to volunteer a minimum of 6 hours per year.
  - If your membership is a family membership, the total of your hours will be six (6) hours.
  - You may volunteer hours working an event or helping on a work crew. Event chairpersons are listed on the monthly calendar and in the newsletter, feel free to contact them and set up time to help out.
  - If your family does not volunteer the minimum six (6) hours per year, you will be assessed a non-volunteer fee \$20.00 for your renewal.
    - This is not to be interpreted as a penalty, but an incentive to help make our club a continued success.
- P&M board meetings are the 1<sup>st</sup> Monday of every month at 6:30 pm in the clubhouse.
- Members free lights Thursdays until 9:00 pm. You may purchase lights at other times for a nominal fee.
- You may use the arenas, warm up areas and round pen any time from dawn to 10:00 pm; unless there is an event running or the arena is being prepped for an event.

### **General Rules**

- No alcoholic beverages on grounds

- Long pants and proper foot wear must be worn (Boots are strongly recommended, closed toe shoes required in arena, or on horseback)
- No abusive language, unsportsmanlike conduct or abuse to animals will be tolerated
- No running horses outside arenas/warm up areas
- Children will be kept under control by parents
- No horses around cook shack or bleachers
- Dogs must be on leash at all times
- Membership required for anyone horseback, you can purchase a daily membership for \$5.00 / person
- Watch for dust, we can be fined by the county for excessive dust, if necessary; water can be purchased prior to arena use for a nominal fee.
